POLITICS ACROSS BORDERS: IMMIGRATION, NATIVISM, ACTIVISM AND TRANS-BORDER POLITICAL SENTIMENT

The Andrew W. Mellon Foundation has awarded a grant of \$225,000 dollars to Rutgers University—Newark to support a Sawyer Seminar on the Comparative Study of Cultures entitled "Natives and Nativists, Migrants and Immigrants in an American City"

The seminar series will be organized by Belinda Edmondson professor of African American and African Studies, Kornel Chang, associate professor in History and American Studies, and Sean Mitchell, associate professor in Sociology and Anthropology.

Based at Rutgers-Newark, a university with a highly diverse student body, a highly active scholarly faculty, and deep roots as an anchor institution in the city of Newark, this seminar series will examine the past, present, and future of Newark in order to examine race, inequality, and immigration in the constantly changing immigrant cultures of America's cities

It comes at an especially critica moment in our nation's history, when race, immigration and inequality can no longer be ignored or sidelined.

In the project abstract, the researchers assert that during the current global pandemic, the future of US cities—of immigration and urbanization; nativism and inclusion; gentrification and urban abandonment—has been thrown into question in a way that has not been true for decades or perhaps more. "Newark, NJ has long been a microcosm of such conflicts, in both reality and in popular imaginations.

From the Jewish Newark threatened by US nativism imagined in Philip Roth's *The Plot Against America*; to the Newark o an African American uprising and white flight of the 1960s and 1970s to today's Newark of diverse immigrant populations and fraught immigrant politics; to the alwayson-the-cusp of gentrification Newark, imagined by developers to be "the next Brooklyn" there is no better site to think through the tensions of urbanization brought to light by the COVID-19 pandemic than Newark."

During the Fall 2022 and Spring 2023 semesters, "Natives and Nativists, Migrants and Immigrants in an American City" will comprise of a series of panels and workshops that draw on the expertise and research projects of Rutgers-Newark faculty and graduate students, local, national, and global scholars, and bring together community activists, scholars and local artists who focus on these issues.

THURSDAY, OCTOBER 27

POLITICS ACROSS BORDERS: IMMIGRATION, NATIVISM, ACTIVISM AND TRANS-BORDER POLITICAL SENTIMENT

In the context of the scapegoating of immigrants and intensified nativism in US politics, it is often taken for granted by scholars and journalists that members of immigrant communities in the US would automatically reject such politics. However, many immigrants hold seemingly contradictory political positions, informed by multi-national political and economic trends that complicate this simple picture.

This seminar examines the complexity of political sentiment and action among some immigrant communities in the Newark area and beyond. It concludes with a roundtable involving panelists and progressive activists from Brazilian communities in the region

Audrey Truschke, Rutgers University, Newark

Audrey Truschke is Associate Professor of South Asian History at Rutgers University in Newark, New Jersey. She is the author of three books: Culture of Encounters: Sanskrit at the Mughal Court (2016), Aurangzeb (2017), and The Language of History: Sanskrit Narratives of Indo-Muslim Rule (2021). She is currently the recipient of a National Endowment for the Humanities Public Scholars grant to write her next book, a single volume history of India from the Indus Valley Civilization until the present day (under contract with Princeton University Press). When Audrey isn't writing about the Mughals, Sanskrit texts, or Hindu-Muslim interactions, she is often calling attention to abuses of history and human rights in contemporary South Asia. Her other frequent activities include condemning sexism and Islamophobia, reading, and spending time with her family.

Vânia Penha-Lopes, Bloomfield College

Vânia Penha-Lopes is Professor of Sociology at Bloomfield College, co-chair of the Brazil Seminar at Columbia University, a member of the Laboratório de Estudos Negros-LEN at Universidade Federal do Rio de Janeiro, a research fellow at the Washington-Brazil Office-WBO, and a former member of the executive committee of the Brazilian Studies Association-BRASA. A native of Rio de Janeiro, Brazil, Dr. Penha-Lopes graduated with honors from the Universidade Federal do Rio de Janeiro with a Bachelor's degree in Social Sciences (1982) and from New York University, with a Master's degree in Anthropology (1987) and a Ph.D. in Sociology (1999). She is the author of The Presidential Elections of Trump and Bolsonaro, Whiteness, and the Nation (2022), Racismo Lá e Cá: 60 Crônicas (2020), Confronting Affirmative Action: University Quota Students and the Quest for Racial Justice (2017), Pioneiros: Cotistas na Universidade Brasileira (2013), and co-editor of Religiosidade e Performance: Diálogos Contemporâneos (2015). Isabela Kalil, University of São Paulo

Isabela Kalil has a PhD in anthropology from the University of São Paulo. She is a professor at the São Paulo School of Sociology and Political Science (FESPS) and coordinator of the NEU—Center for Urban Ethnography at the same institution. Prior to joining FESPSP, she was a visiting scholar at Columbia University (New York City) in the Department of Anthropology.

IMMIGRANT COMMUNITIES AND GLOBAL POLITICS

Prema Ann Kurien, Syracuse University

Dr. Prema Kurien is Professor of Sociology at Syracuse University as well as the Director of the South Asian Center. She is a scholar of international migration, race, ethnicity, and religion. Dr. Kurien adopts a transnational approach in her work and has also done research in India, to show how a variety of global factors, including developments in the country of origin, play a profound role in shaping community structures, cultures, and activism profiles of immigrants and even the second generation. She is the author of three award-winning sole-authored books, Kaleidoscopic Ethnicity: International Migration and the Reconstruction of Community Identities in India (2002), A Place at the Multicultural Table: The Development of an American Hinduism (2007), and Ethnic Church Meets Mega Church: Indian American Christianity in Motion (2017). She has completed her next book Claiming Citizenship: Race, Religion, and Belonging among New Ethnic Americans. Her work has been recognized with a Contribution to the Field award (in Asian/Asian American Studies), three book awards, and three article awards and she has received postdoctoral fellowships and grants from a wide variety of sources.





Gladys Mitchell-Walthour, North Carolina Central University

Gladys Mitchell-Walthour is Dan Blue Endowed Chair of Political Science at North Carolina Central University. Mitchell-Walthour is the past president of the Brazil Studies Association (2018-2020) and the National Co-coordinator of the US Network for Democracy in Brazil (2019-2022). She is a Board Member of the Washington Brazil Office. She is the author of *The Politics of Blackness* (2018, Cambridge University Press). She co-edited the volume *Knowledge Production* (2016, Palgrave MacMillan) with Elizabeth Hordge-Freeman. She also co-edited the volume *Brazil's New Racial Politics* with Bernd Reiter (2010, Lynne Rienner Press). She is the recipient of numerous grants and fellowships including the Fulbright (2022), postdoctoral fellowships at Duke University and Johns Hopkins University, and was a Lemann Visiting Scholar at the David Rockefeller Center for Latin American Studies at Harvard University (2014). She holds a PhD in political science from the University of Chicago, MPP from the University of Michigan-Ann Arbor, and BA from Duke University.

Meena Dhanda, University of Wolverhampton

Dr. Meena Dhanda is Professor of Philosophy and Cultural Politics at the University of Wolverhampton. Born, brought up and educated in the Indian Punijab, she did her doctorate in philosophy at Oxford University as a Commonwealth Scholar. She is an advocate of socially engaged philosophy, and has conducted transdisciplinary research linking caste, class, race, and gender in projects funded by The Leverhulme Trust and the European Commission's EU Horizon 2020 research programme. She is the author of The Negotiation of Personal Identity, editor of Reservations for Women, and special issues of journals J-Caste and Religions. She led a cross-disciplinary consortium of experts producing two research reports on 'Caste in Britain' (2014) for the Equality and Human Rights Commission, UK. Currently, she is a beneficiary of an EU Horizon 2020 Innovative Training Network project FEINART (2021-24), supervising Early Stage Researchers working on socially engaged art, political philosophy, cultural theory and art practice. She is consolidating her recent published papers on: anti-casteism and misplaced nativism, philosophical foundations of anti-casteism, the power of counter-rituals, the simulation of caste-blindness, and the concurrence of anti-racism and anti-casteism, into a monograph.

Eduardo Vianna, City University of New York and organizer, formerly with Defend Democracy in Brazil Eduardo Vianna is a Professor at the City University of New York (CUNY) in the following programs: the psychology program at LaGuardia Community College and the developmental psychology and urban education Ph.D. programs at the Graduate Center. His research focuses on connecting teaching-learning and developmental processes in various settings that serve underprivileged and minoritized populations. Working from a Vygotskian perspective, especially the Transformative Activist Stance approach, he has carried out research on applying critical-theoretical pedagogy in a community college. This includes building a peer-based co-curricular program to connect affect and agency in learning. He is the lead editor for Outlines. Critical Practice Studies and has been directly involved with Brazilian activist groups in New York fighting for democracy and social justice, including developing popular education initiatives.

Natalia de Campos, Performance artist and activist, Defend Democracy in Brazil Committee, NY

Natalia de Campos is a multidisciplinary performance artist and producer, educator, writer, translator and activist from \$30 Paulo, based in New York since 1998. A co-founder and co-director of the performance & political activist group Defend Democracy in Brazil Committee in New York since 2016, with whom she organized over 250 street actions, lectures, media actions and more. Natalia works in performance & theatre, interactive media, social practice, and street interactions, as a theater actor, director, and producer of solo or collaborative works under Syncretic Pleasures, ART&COM, and United Artists & Activists Union. She has presented her own work in venues around downtown NYC. Performed and toured to Brazil with The Living Theatre, performed in Mikhail Baryshnikov's White Oak at BAM, and others. She's a member of the Lincoln Center Theater' Directors Lab; holds an M.F.A. in Performance & Interactive Media Arts (CUNY) B.A. in History from the University of \$30 Paulo. Presented her research at the International Theater Conference in Santiago, Chile, and also lectured in multiple events at New York University following the election of Bolsonaro, at the USNDB annual meeting at the George Washington University in D.C., among others. As a coordinator and curator, she organized political education events about Brazil at CUNY, NACLA, NYU, The People's Forum, the LEFT Forum at LIU, Columbia University, GWU, and with the international network of Brazilian activists, FIBRA, among many others. Natalia currently teaches Portuguese and about Brazil's Social Movements at The People's Forum in New York. Iliana Smith, Graduate Assistant


